

## Privacy Notice for Center for Biomedical Research

### Introduction:

At the Center for Biomedical Research, we are committed to maintaining the trust and confidence of our research participants, partners, and visitors to our website. In this Privacy Notice, we detail why we collect personal information, how we use it, the conditions under which we may disclose it to others, and how we keep it secure.

### Types of Data We Collect:

- **Right to Rectify:** You can ask us to rectify any information you believe is inaccurate.

- **Right to Erase:** You can ask us to delete your personal data, though this may not be feasible if the research is ongoing or if there are legal, ethical, or regulatory reasons to retain the information.
- **Right to Restrict Processing:** You can ask us to temporarily halt the processing of your personal data.
- **Right to Object:** You can object to the processing of your personal data in certain circumstances.

**Retention of Data:**

Your data will be retained only for as long as necessary for research purposes or as mandated by legal, ethical, or regulatory guidelines. Per FDA, ICH, and GCP regulations, one year after the end of the clinical trial period, the paper data will be relocated to an offsite storage facility. After the mandated storage period, any personal identifiers will be removed, or the data will be destroyed.
